I'm thrilled that you're considering working with me to bring your vision to life.

Before we get started, I want to **ensure** that we're **on the same page** and that **you understand my terms of service**.

As a digital artist, I **take pride** in my work and **strive** to provide **the best possible experience** for my clients. I'm **here to help** you **bring your unique vision to life**.

To **ensure** that our collaboration runs **smoothly** and that we're **both happy** with the **final result**, I have **a few terms of service** that I **ask my clients to abide by**.

These **terms** are **designed** to **protect both of our interests** and ensure that we have a **clear understanding** of what to **expect** throughout the **commissioning process**.

Please take a moment to **review my terms of service before we begin**.

If you have **any questions** or **concerns**, don't hesitate to **reach out to me**.

I'm excited to work with you and create an artwork that is uniquely yours!

Customer satisfaction

- ❖ I will do **everything** I can to make **my clients satisfied** with their commission(s).
- ❖ If you have **any problems** regarding the commissioned piece, please **tell me right away**, so we can find a **solution together**.
- ❖ Your **entire satisfaction** is my **end goal**, so **communication** is the **most important** part of the commission process.
As such, if you have **some issues with communication**, please **don't hesitate** to **let me know** beforehand, so I can **adapt to you**.

General guidelines

- ❖ By commissioning me, you agree to have read and fully agreed to my terms of service.
- ❖ Prices shown are for personal use only.
- ❖ I retain all the rights to my work, which include but are not limited to the right to distribute, reproduce, copy, and/or use the image as a sample for sales or self-promotion.
- ❖ I do NOT authorize using any of my pieces as NFTs (Non-Fungible Tokens).
- ❖ Furthermore, I do NOT authorize using any of my pieces to feed any AI generator or use in an AI generator in any way.
- ❖ I reserve the **right to refuse any commission**.
- ❖ Any **disrespectful behavior** will **not be tolerated**.
- ❖ Please write clearly and sympathetically.
- ❖ I **work best** when **given artistic freedom** to create an image based on the characters you provide. I am **happy** to **match a scene** or **pose that you have in mind**; **please allow** and **expect some variations**.
- ❖ I may use **photo bashing** and/or **3D** on my commissions if I see fit at my own discretion.
- ❖ **Price will vary** depending on the **complexity** of the **character design, background, or other elements I deem fit**.

Customer use

- ❖ The commissioner reserves the right to:
 - **Claiming rights** to the **character**, but not the drawing itself.
 - **Sharing/Reposting** the artwork anywhere they see fit, with **proper credit**.
 - **Printing** the artwork for **personal use** only.

The following is considered copyright infringement:

- **Reproducing/using** copyrighted artwork commercially without my knowledge.
- **Claiming the artwork as your own**.
- **Removing** my **signature** from the artwork.
- **Changing** the artwork **without my consent**.

Payment

- ❖ At the moment, I only accept payment via **PayPal, Stripe, or E-Transfer**.
- ❖ I will **send all invoices** and only accept **\$USD or \$CAD** as payment!
- ❖ **Payments** can be either :
 - **50% before I start your commission** and **50% before I send the finished piece**.
 - OR **50% before I start your commission** and **50% while I'm finishing the piece**.
 - OR **100% before I start working on your commission**.
- ❖ If the **commission amount** is over **\$200**, **payment plans** are available for **returning customers only!**
- ❖ I will **ONLY** start working on your commission after receiving the **full** or the **first installment** of the agreed payment.
- ❖ **! Rush fee means that you will be put at the top of my to-do list !**
We can discuss **how much** together.
- ❖ Please give me a **realistic deadline**: I can't make a **fully detailed** illustration in **less than a week**.

Rights rates

- ❖ **Personal rights** are **free** of charge.
- ❖ **Private rights** are an **extra 50%** of the final quote price.
- ❖ **Commercial rights** will be decided **case by case**.

Refunds and canceling

- ❖ **I don't do refunds if I started working on your commission.**
- ❖ **Sales of all physical goods (i.e., stickers, prints, etc.) are final.** No refunds or replacements unless the damage/poor quality is from my error before sale.
- ❖ You'll receive a **full refund** if, for any unjustifiable reason, I'm **unable to finish the commission**.
- ❖ **After 3 days of an unpaid invoice, your slot will be forfeited if another person pays in due time.**

Delivery time

- ❖ Commissions *may* take, upon starting :
 - **5+ days** for **Profile Picture**.
 - **10+ days** for **Character Art**.
 - **25+ days** for **Illustration**.
 - **35+ days** for **Landscapes, or other complex projects**.
- ❖ The **time of delivery** is based on **active buyer responses** to my inquiries, **delay may arise** if not.
- ❖ **Delays may arise** depending on the next factors: **order of commission, complexity, health, work, school, or family issues**.
- ❖ **If delays arise, you will be notified.**
- ❖ If you choose a **payment plan extending over the delivery time**, **delays** before completion **will rise**.
In this case, I will work on your commission **as much of the payment I have received²**.

² i.e.: half of the payment the first month means half of the commission done by the end of said month.

Commission's information

- ❖ **Provide numerous useful references. I can guide you if needed; just state it.**
- ❖ In the case where you have **any size, resolution and/or color mode requirements**, please **inform me as soon as possible**.
If I **already created** the file and **worked on it**, I might **not be able to change it**.
- ❖ If I have to find **references myself**, an **additional 50% charge** of the final quote price will be added.
- ❖ If **references provided are unclear or lacking**, an **additional 25% charge** of the final quote price will be added.
- ❖ **You'll be notified if I added reference fees to the final quote price, so we can discuss it if needed.**
- ❖ A description of the **wanted commission** is **required**; the **more details, the better!** You can also try to sketch your idea in MS Paint: I'll take everything!

- ❖ What you need to send me³ :
 - **Type of commission :**
 - **Pictures of the character/OC :**
 - **Picture(s) of pose idea(s) :**
 - **Pictures of background(s) :**
 - **Pictures you like the mood/colors of :**
 - **Description:** (i.e: who, doing what, where, when, why, for what)
 - **Budget range :**
 - **Any other things you can think of, or deem important** (optional)

Commission process/Workflow

After sending me the filled form, I'll ask for more **details** if needed and **answer any of your question(s)**! Then, I'll **come back** to you within **24 hours** to give you **my quote price**.

After **finding common ground**, **getting the first invoice** & **giving the completion date**, I'll start **working on your commission**. I will also **add** your commission to my [public Trello board](#)* for viewing and keeping tabs on the **progress of your piece**.

❖ **Step 1 or Thumbnailing/Sketch stage**

I'll **sketch** some ideas with **black-and-white values**, then show them to you so you can **choose and/or tweak one to your liking**.

You can expect **4 thumbnails minimum**, up to a **dozen** if I feel inspired and/or if artistic freedom is given to me.

❖ **Step 2 or Colour stage**

I'll **color** the thumbnail of your choosing.

You can expect **4 thumbnails (coloring minimum)** up to a **dozen** if I feel inspired and/or if artistic freedom is given to me.

❖ **Step 3 or the Refining stage**

I'll **refine the sketch**, meaning **working on details** in the **background** and **character(s)**. **This is what your commission will look like** before I render it further.

❖ **Step 4 or the Rendering stage**

The most **time-consuming part**; I might **not be able** to **update you** as much as before because I'll need to **focus** on the piece.

However, feel free to **DM me** to see the advancement.

❖ **Step 5 or Final effects**

I'll be adding **effects** and **filters**. You'll receive two files, one with it and one without.

❖ **Step 6 or Sending files**

Finally, you will receive a **signed digital file** via **WeTransfer by email** to not compress the quality. If the file is too big, I'll use another image hosting website.

Once the **commission is finished**, **no more changes** or **edits** can be made.

If I have permission to **post on social media**, I'll put a **special watermark** on it.

Revisions

- ❖ Commission revisions are the next :
 - **Profile Picture**: 2 revisions during sketch & base color stage.
 - **Character Art**: 4 revisions during thumbnailing, color & refining stage.
 - **Illustration**: 6 revisions during thumbnailing, colors & refining stage.
 - **Landscape**: 8 revisions during thumbnailing, colors & refining stage.
- ❖ Additional revisions after the steps stated previously will be charged 5-20% of base price, depending on complexity.
- ❖ If you wish to **change a part of the painting you have previously approved**, I will charge you an **extra fee**.
- ❖ In the case where **artistic freedom is given**, I will work based on **my judgment**. However, if the client requests a **scrapping of the scene** in its **majority** or **entirety**, they'll be **charged again**.
- ❖ Any mistakes from my end will be fixed for free.

Do and Don't

Please keep my art & thematic style in mind when ordering, which is focused on character/character design/cell-shaded or full-rendered illustration in a **semi-realistic or cartoony style**. (Unless commissioning a semi-realistic pet portrait commission, in which case please reference my previous pieces on Instagram, Facebook page, or my Bluesky).

Don't hesitate to ask me if you're wondering if your commission idea matches my art aesthetic.

- ❖ **Do :**
 - Humans.
 - Ferals.
 - Anthros.
 - Furry.
 - Monsters / Creatures / Animals.
 - Most Original Species.
 - Original Character.
 - Fanart.
 - Mild Gore & Horror.
 - Robotic parts.
 - NSFW of any sexuality.
- ❖ **Don't :**
 - Pure mecha.
 - Hateful content.
 - Imitation of any art style or artist.⁴

⁴ Examples of art pieces to guide me on the vibe or composition you are looking for are more than welcome, **HOWEVER** don't ask or expect me to copy them.
